Planning and Zoning Commission – Oversees the city and zoning plans; approves or disapproves of plans, zoning requests, plats, or replats; plans public rights-of-way, parks, or other public places; makes recommendations regarding the general design and location of public buildings, bridges, viaducts, street fixtures, and other structures; recommends the location and/or operation of utilities, public facilities, and services owned or under the control of the city. All recommendations are submitted to the City Council for final approval.

Type A Economic Development Corporation – Recommends usage of the City of Grandview's Type A Sales Tax to fund land, buildings, equipment, facilities expenditures, targeted infrastructure and improvements for projects including manufacturing and industrial facilities, recycling facilities, distribution centers, and small warehouse facilities; research and development facilities, regional or national corporate headquarters facilities, call centers, aviation facilities, and others allowed by the State of Texas. All recommendations are submitted to the City Council for final approval.

Type B Economic Development Corporation – Recommends the usage of the Type B sales tax for any project eligible under Type A rules and several other project types, including quality of life improvements. Type B corporations may pay for land, buildings, equipment, facilities, targeted infrastructure and improvements. The board may also use funds to promote and develop new and expanded business enterprises that create or retain primary jobs. All recommendations are sent to the City Council for final approval.

Grandview Housing Authority Board - The Grandview Housing Authority provides safe, decent and sanitary housing for low-income families in the city limits of Grandview. The Board is responsible for ownership, maintenance, operation and legal compliance of the existing inventory of low-rent public housing in Grandview. The board is also responsible for the development of new housing opportunities for low- and moderate-income families. They act as the policy-making body for the Grandview Housing Authority.
